Power Pack Installation



When your light is worn on the left shoulder:

Go to ①

When your light is worn on the right shoulder:

Go first to ④

Slide the belt clip at the back of the holster over the braided bar.

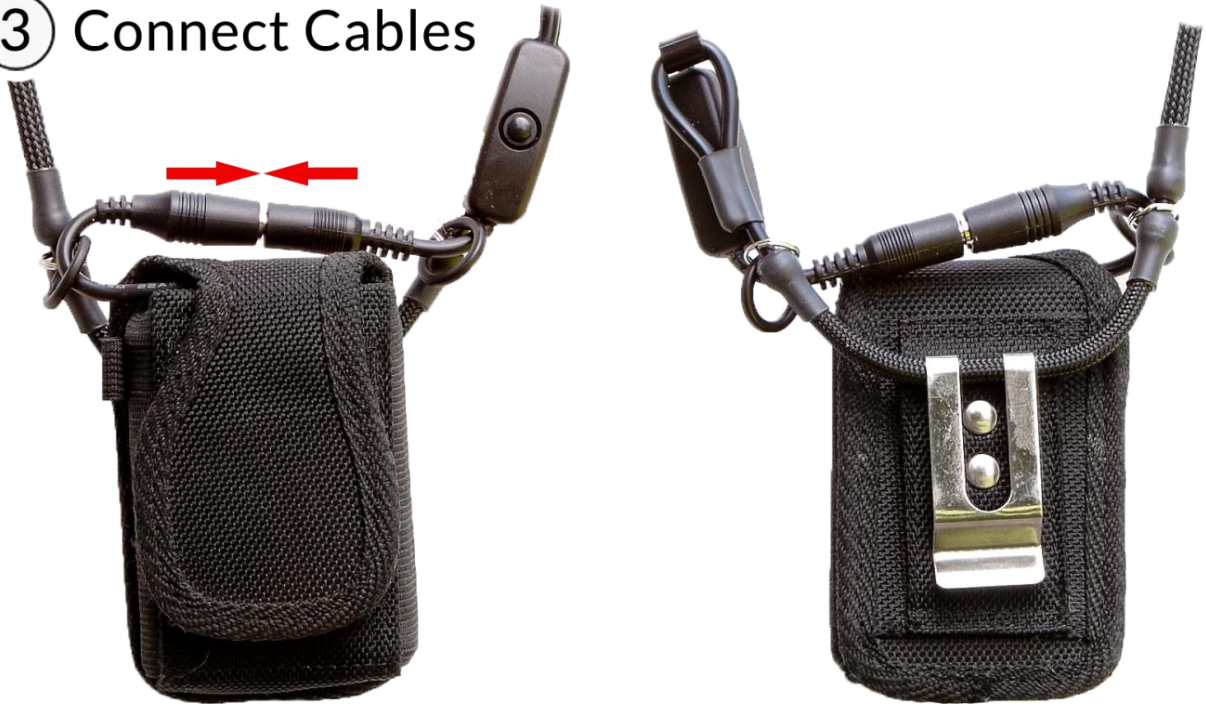

Insert the battery cable through the cable ring.

Lumenflex warrants our products against defects in material and workmanship for a Warranty Period of one (1) year from the date your purchase is shipped within the U.S. and Canada. In addition to our lighting products, the limited warranty covers our proprietary li-ion battery packs.

If a defect arises and a valid claim is received by Lumenflex within the Warranty Period, we will repair or replace the product at our discretion. We warrant any repaired or replaced products against defects in material and workmanship for the remainder of the Limited Warranty Period of the original product.

Lumenflex will arrange and cover return shipping costs within the U.S. and Canada for any product covered by the Limited Warranty. If repair or part replacement costs apply because the defect is not covered under the Limited Warranty, you will be notified prior to any service. The customer is responsible for all shipping costs of items not covered by the Limited Warranty.

THIS LIMITED WARRANTY IS IN LIEU OF ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.

Custom designed lighting products are not returnable.

Return shipping costs are non-refundable.
